We Were Not "Allowed" to Win the War in Vietnam

he Second IndoChina War - the fall of Saigon and the conquest of South Vietnam, Cambodia, and Laos by the communist invaders from North Vietnam - ended nearly 31 years ago. The North Vietnamese communists defeated RVN (Republic of South Vietnam) two years after the last U.S.A. and ROK (Republic of Korea) combat

forces departed South Vietnam in March 1973. To be clear, American forces did not lose the war in Vietnam. South Vietnam fell after its U.S. and Allied support was withdrawn.

The U.S.A. forces lost some firefights with the communist Vietnamese, but it won nearly every battle, and virtually every campaign. So why wasn't the war won before the USA withdrew the last of

Iraq or Bust

Tn 1968, Jerry Williamson and Eric Newton deployed to Vietnam for a one year tour. Their mission—wage a protracted war against a guerrilla element bent on destroying a fledging democracy. Operating in around the III Corps area near Saigon, both men were vehicle commanders.

During their seven day stay. Williamson and **Newton were** allowed unprecedented access to Task Force 2nd Squadron, 11th **Armored Cavairy** Regiment.


Williamson served as a Specialist-5, or "Spec 5," in Delta Company, 1-11th Armored Cavalry Regiment. Newton was a Sergeant in Kilo Troop, 3-11. Williamson went on to pursue several careers as a policeman, private investigator, and a therapist. He is now retired.

Newton became a contractor, a job he still holds today.

Both men served in Vietnam with distinction in the same job in sister battalions, but both men never met, not until about a month ago. A meeting that never took place in one foreign land finally became actualized in another, where a



its forces in 1973? There are many contributing factors, but the most significant and compelling single factor is that the Allied anti-communist military effort (consisting primarily of South Vietnam, USA, South Korea, Australia, and New Zealand forces) in South Vietnam was doomed to fail from the start because of strategic restrictions placed upon it. The most militarily significant of these restrictions can be best summarized with one word: Sanctuaries. Blackhorse fought an enemy for six years in and around War Zone C that was fully resupplied and reinforced from these hidden safe havens on the other side of the Cambodian border.

The shortest distance from North Vietnam at the DMZ through South Vietnam to Saigon is about 400 miles. It was an impossible task for North Vietnam to supply its army that far through South Vietnam because the NVA would be attacked the entire way by RVN and its Allied forces once it crossed the narrow DMZ. Instead, the NVA communist forces established its logistical bases and roads a few miles inside "neutral" Cambodia and Laos.

North Vietnam threatened the governments of both Laos and Cambodia, and forced them to allow it to bring its military supplies and reinforcements through the western parts of those two "neutral" countries. In addition, the NVA built scores of giant supply bases in both "neutral" countries. North Vietnam knew that the U.S. Congress and the United Nations prohibited ground interdiction to close those illegal supply lines.

The existence and importance of the communist *sanctuaries* may be the most overlooked or ignored subject by the media in its coverage of the war. International politics beginning at the United Nations set the groundwork for this war-winning communist asset. First, a little background.

- Post-WWII 1945. Rule of Indochina was returned to France after Chinese leader Chiang Kai-shek stated he did not want Indochina, "They are not Chinese. They would not assimilate into the Chinese people."
- Ho Chi Minh lobbied for U.S. support for independence from France, but

after the fall of China to Communism in 1949, the U.S.A. would no longer ally itself with any communist organization or nation.

- 1950. United Nations mandated supporting South Korea to expel the North Korean and Chinese invaders during the Korean War of 1950-1953. Important: The U.N. mandate had the approval of the Soviet Union because of is rivalry with its neighbor, China.
- 1954. French forces are defeated by the Viet Minh during the epic battle at Dien Bien Phu, and the First Indochina War ended soon thereafter. The Geneva Conference on Indochina agreed to split Vietnam into two independent nations along the 17th parallel (as it was split in the 15th Century), leaving North Vietnam under communist control and giving South Vietnam an opportunity to develop a democracy. The Geneva Conference on Indochina also granted Laos and Cambodia their independence, with Laos returning to its 600-year old monarchy.
- The Soviet Union (one of North Vietnam's major allies) made it clear to the U.N. that it would veto any attempt by the U.N. to mandate support of RVN in its efforts to expel its communist invaders from North Vietnam. This U.N. manipulation and philosophy was also carried forward with the U.N. views on Cambodia and Laos for twenty years of warfare 1954-1975 as the North Vietnamese military activity in those countries was completely ignored by the U.N.
- The **1962 Geneva Conference** on Laos forbid the U.S.A. to enter eastern Laos in any attempt to stop the flow of NVA troops and supplies down the Ho Chi Minh trail network, thus giving a "green light" to the NVA.
- 1965. The U.S.A. ground troops entered into the Second Indochina War to aid its ally South Vietnam *without sanction* or assistance from the U.N., much like the

U.S.A. did with its attack on Iraq after 9-11.

The fact that North Vietnam was violating the neutrality of Cambodia and Laos was of no consequence to the U.S. Congress or the United Nations in the prohibition of American ground forces entering those "neutral" countries to eliminate the NVA base camp sanctuaries or to stop the communist infiltration into RVN.

North Vietnam had the ability to supply its invading army from sanctuaries and road networks (primarily the Ho Chi Minh Trail) through Laos and Cambodia with impunity from intervention and ground attack. Furthermore, North Vietnam received unlimited supplies from China, Soviet Union, Czechoslovakia, Cuba, North Korea, East Germany, and numerous other communist bloc countries through its ports including the North Vietnam's giant Hai Phong harbor, and the Port of Sihanouk in Cambodia only a few miles from the South Vietnam border on the Gulf of Thailand.

The sanctuaries were not just a place for the communist forces to hide. The sanctuaries provided training and R&R for its soldiers, as well as resupply, reinforcements, medical care, operational headquarters, food storage, motorpools, fuel depots, communication networks. weapons and munitions storage facilities, and thousands of miles of roads comprising the Ho Chi Minh Trail network. And there was nothing the South Vietnamese, U.S., South Korean, Australian and NZ forces could "legally" do about it. The end result was that Allied forces could only fight the NVA when they caught them inside South Vietnam. In other words, the war had to be fought on terms dictated by the communists because of their ability to "hide" on the other side of the border.

Special Forces missions with Montagnard, Thai, and Cambodian mercenaries spied on and harassed the Ho Chi

Minh trail network. The CIA and U.S. Air Force conducted their secret war in parts of Laos against overwhelming odds. As a Platoon Leader in early 1970, I witnessed cheers from my Blackhorse troopers on the Cambodia border as President Nixon's secret B-52 bombing raids pounded NVA base camps just a few kilometers away on the Cambodian side of the Fishhook.

The 1970 joint ARVN-USA limited 60-day "incursion" into Cambodia had enormous success in terms of enemy supplies captured, and changed the course of the war in War Zones C and D, and in the Mekong Delta for nearly 18 months. It was the only official operation by U.S. ground forces to attack the communist sanctuaries during the course of the war.

Could an Allied military victory have been achieved without a ground invasion and without conquest of North Vietnam? Most likely "Yes" *if* the resupply of the communist forces was cut off through the following measures:

Ground interdiction of the Ho Chi Minh trail network in Laos and Cambodia to stop the flow of supplies.

Elimination of NVA base camp sanctuaries in Laos and Cambodia.

A naval blockade of military supplies arriving by ship in North Vietnam and Cambodia's Port of Sihanouk.

Continued bombing of military targets inside North Vietnam.

For example, the massive U.S. Linebacker II bombing campaign of North Vietnam and U.S. naval mining of the Hai Phong harbor quickly forced the NVA to sign the Paris Peace Agreement. However, because steps 1 and 2 above were not accomplished, the NVA quickly reverted to its old tactics after the U.S.A. forces withdrew and the POWs were freed.

Had South Vietnam's democracy succeeded, the United States and the Free World could have had a strong economic, military, and political ally with superb deepwater ports in a highly strategic Asian location today. More importantly, the people of South Vietnam would be free and not oppressed as I observed while I visited the country in 2005. Yes, the people of Vietnam are not dying in war today, but they are not free. Today Vietnam is listed as one of the most oppressed, and among most poorest and corrupt nations on earth.

My class was relatively large so attendance was large and also a good size contingent of us (including myself) went center stage. To my pleasant surprise, my classmates then spontaneously gave us a standing ovation. Peer recognition had finally occurred and it was a pleasant feeling.

Later, I ran into a classmate at the reunion that was a Vietnam Veteran and had not joined in the activity. I asked him why. His response illustrates the irreparable sting he had felt by not being *properly* welcomed home. He said, "They can take their thanks and shove it, they are too late for me." Some of us felt and carried the sting a very, very, long time and this should never be allowed to happen again.

The annual Veterans Day wreath laying will be held at 10:00am on Saturday, November 11, 2006, at the Vietnam Veterans Memorial.


11th Armored Cavalry Welcome Home Party

The 11th ACR deployed as a trained unit and returned as a successful participant in the war against terrorism in Operation Iraqi Freedom III.

All 11th ACR Veterans were invited to attend and take part in the celebration at Fort Irwin. We thank the Regiment, its Commander, COL Peter Bayer and Command Sergeant Major (CSM), Ricky Pring, for including us in the festivities. The cel-

ebration and mutual appreciation of the sacrifices made by the Regimental Troops in Iraq and those same sacrifices that we made in Vietnam and Cambodia showed us that we are all part of the mystique of the "Blackhorse Regiment". We respect and admire today's Troopers, and they in turn respect and admire the legacy we established some forty years ago in the jungles of Vietnam and Cambodia. As the present and former Regimental Commanders inspected the troops from a WWII halftrack, each unit was saluted and acknowledged. As they passed in review, it was again obvious we were observing a proud unit that had distinguished itself in defense of our freedoms. We cannot express our thanks and gratitude thoroughly enough for all that these soldiers have done and continue to do for all of us by their selfless service!

new generation of Soldiers is again fighting to bring peace and democracy to a war-torn country.

Members of the 11th ACR Veterans of Vietnam and Cambodia Association, Williamson and Newton both felt the urge to visit Iraq, to reconnect with the unit that they last fought with over 35 years ago when the two men were just young Soldiers. By gaining support from the present chain of command, the two men came to Iraq together to see the Soldiers who continue to carry on the Blackhorse tradition.

During their seven day stay, Williamson and Newton were allowed unprecedented access to Task Force 2nd Squadron, 11th Armored Cavalry Regiment. From living in a forwarding operating base to going out on counterinsurgency patrols, the Vietnam Vets were able to witness the full spectrum of operations that the 11th ACR Soldiers have been conducting in their deployment to Iraq.

Task Force 2-11 ACR, operating out of FOB Kalsu approximately 30 miles south of Baghdad, took Williamson and Newton out on patrols where they were able to participate in a raid and witness the clearance of an improvised explosive device. They were also able to sit in on several staff meetings, allowing the Vets to see both the planning and execution sides of

the Task Force's missions.

Towards the end of their visit, Williamson sat down for an interview. He did note the similarities between Vietnam and Iraq. However, he insisted that while today's Soldiers have better technology available to them compared to his counterparts, the jobs of the Soldiers of today have also increased in complexity. Soldiers now have to act more like policeman and must walk an even finer line between fighting an insurgency and winning hearts and minds.

Still, Williamson did not express any concern about the state of the Army or its current mission. In fact, both men were impressed with the competence and pro-

fessionalism of all the Soldiers they met. The two veterans were adamant that the Army needs to be allowed to finish their mission in Iraq.

The following information is provided to help member's understand how our Scholarship Program was developed and how the program works.

Guide To 11th ACVVC Scholarship Program

HISTORY

11TH ACVVC began collecting money at the 1989 Reunion in Minneapolis. \$1,000 was donated to the Blackhorse Association Scholarship Program.

At the 11TH ACVVC Membership Meeting during the reunion in 1996, it was decided by the membership to begin a Scholarship Program separate from the Blackhorse Association.

Below is a list of Scholarship's that have been provided:

| 1997 – 2000 | 46 Scholarships of \$2,000 each |

| 2005 | 25 Scholarships of \$3,000 each |

As of June 30 2005, 142 Scholarships have been awarded for a total amount of \$380,000.

In 2001, the Board of Directors voted to use the monies that are generated by the interest received from the Association's Certificates of Deposit for the Scholarship Program. Additionally, the fundraising activities that we participate in each year add to the total scholarship funds. These activities include Calendar Sales, the Raffle and a Silent Auction each year at the annual reunion. Your support makes this program work.

Prior to the 2001 Scholarship season, applicants were judged, in addition to the existing categories, also on the basis of financial need.

To determine financial need required the scholarship committee to make financial needs judgment's and decision's with very limited personal financial information available. Furthermore, divorces, varied costs of living and salaries in different areas of the country made it almost impossible to have one standard to apply to all members. Some applicants felt that the financial need consideration was often prejudicial. It seemed unfair to some student applicants and also prevented many, otherwise eligible students, from applying.

It was decided that the intent and spirit of the 11TH ACVVC Scholarship Program was to benefit the children of all members - and members themselves if qualified. After a long discussion, the consideration of financial need was removed from the criteria.

THE CRITERIA FOR ELIGIBILITY

11TH ACVVC Scholarship Applications will be accepted from;

- Troopers that are current members in Good Standing
- Children and Stepchildren of Current members in Good Standing
- Children whose legal guardian is a Current Member in Good Standing

Applications will be accepted from applicants whose membership or whose parents' membership has lapsed by the Veteran sending in one year's membership fee.

THE APPLICANT

The applicant must fill out the Scholarship Application Form completely. The completed Scholarship Application must be received by

the Scholarship Chairman **no later than the deadline of May 15** of each year (Extended to 31 May for 2006).

Applications received after the deadline or not filled out completely Will Not be considered.

The application is available on the website at: www. 11thCavNam. com. An Application may also be requested by mail or e-mail from the Scholarship Chairman shown above.

The application should be submitted in the two page format as displayed on the website.

JUDGING

Scholarship Applicant's are judged in three categories:

I Form Completion & Legibility

II Grades

II Written Response to the two questions on page 2 of the 11TH ACVVC Scholarship Application

The Scholarship Committee may offer a priority of Scholarship's to Children of those Killed In Action, and to Children of those who Died of Wounds. These are the only criteria that takes precedence over judged items I through III above.

The Scholarship Chairman or Committee Member selects the Judges. The Judges are usually selected from the community where the Scholarship Chairman or Designated Committee Member resides. The main consideration for selection of Judges is that they must be impartial, educated and that they have a good idea of what it takes to succeed in College.

The judges are asked to rate each applicant on a point system. The point total for a perfect score is 30. Up to 15 Points may be awarded for Items I and II above. The remaining 15 points are allocated to Item III above.

Judges' scores are totaled. Applicants are then listed in descending score order. The number of Scholarship Recipients is based on the amount of funds available to award \$3,000 Scholarships. As many Scholarships as possible will be awarded.

Selected Recipients of the 11TH ACVVC Scholarship should be notified in writing by the end of June. The Recipients Letter will include a set of instructions to have the Scholarship Funds sent to the Educational Institution they are attending.

Following the instructions will expedite payment of the scholarship money.

SUMMARY

The 11TH ACVVC Scholarship Program is intended to benefit all qualified people associated with 11TH ACVVC membership. We will continue to award Scholarships so long as our membership supports the Program. We thank the thousands of Trooper's, their supportive families, loved ones and all who have contributed so generously over the years to make this program a success. All of us together, contributing what we can, have helped make this program one for which we can all be proud.

Most of us have heard of the mythical "Fiddler's Green", the "...good old time canteen" located "Halfway down the trail to Hell". Legend has it all Cavalrymen stop here for a drink with departed comrades and never leave.

In reality, we will all depart this world at some time. The loosely organized and informal 11th ACVVC Funeral Honor Guard renders the last respects for fallen comrades by simply attending the viewing or funeral service of deceased Blackhorse Troopers.

Any member of the 11th ACVVC who lives within an hour's drive of the funeral service might get a call from me asking that they attend a viewing or funeral service. All I request or expect of attendees is that they dress neatly, introduce themselves to the family, tell them you served with the Regiment in Vietnam and are paying your respects and expressing your condolences to the family of a fellow Blackhorse Trooper.

To accomplish this last farewell, I need to be informed whenever you know of the death of a Blackhorse brother. Please contact me directly at the number and/or e-mail above. If you can provide date/time/details of the viewing and funeral service, it will make the task easier. It should be mentioned that with the increase in cell phone usage many areas have had Area Code changes and overlays. When I call Troopers, it is common for me to have a 50% failure rate due to an area code that is no longer valid. It is important for this function – as well as many others within the 11th ACVVC – that you contact Allen Hathaway (Membership Chairman) any time there is a change in your phone number, area code or address! I've been doing this for many years, and have received callbacks and notes from Troopers who were contacted for the first time to attend a funeral service – all were honored to do so and reported the family was very grateful that we never forget our brothers. It is the last service we can provide for our Troopers and their families.

Chaplain's Corner

WEAPONS

A few years ago my wife and I visited the site of the Battle of the Little Big Horn in Montana. It used to be called Custer's Last Stand. Then people realized that the Indians (OK, Native Americans) had a point of view too, so the name was changed. It's better this way. It was a very historic battle for our country. The weapons in the battle had a lot to do with the outcome, as you would expect. The Indians effectively used bows and arrows and short range rifles. They had tomahawks and knives for hand to hand fighting. On the soldiers side they had long range rifles which were effective until the Indians got the upper hand and took them. I think the soldiers had knives too but they relied mainly on their long range rifles. That became a disadvantage when the Indians got close.

Over in Viet Nam - whaaaat? Viet Nam again? Don't interrupt. Yes, Viet Nam again - that's where we were. You're not old enough to have been in Montana under Custer. Or under Sitting Bull either. Back to my subject - we had all sorts of weapons in Viet Nam. Many were state of the art in those days. As you know, the M16 was the standard rifle. Maybe you preferred the M14, which some did, especially the snipers, as they've told me. I don't know all the ins and outs of the M16 vs. the M14. I just know there were a bunch of both there, but mostly M16s.

For my first tour I was with helicopters and bird dog spotter planes. I remember our helicopter gunships. They were pretty old at the time, being Bravo model Hueys. We had newer Charlie model Huey gunships at Vinh Long which was our sister airfield about sixty miles north. C models were about the same as B models as far as I could tell. Old or not, those B model gunships were deadly. Our pilots were good. My memory is doing pretty well today and I recall that our gunship pilots could get their helicopters into the air within seconds of the first round landing when we were

attacked. Those were the times when some of the pilots flew buck naked. Their skin was on the line and being fast counted more than having their skin covered. This didn't happen all the time, just when rounds were actually hitting. They joked about it. To be honest, I thought it was pretty funny too. Mostly, I was glad they were good at what they did. I didn't care that they were in the raw. Our gunships carried side mounted M60 machine guns, automatic grenade launchers, rocket pods and whatever else they needed to bring skunion upon the heads of the NVA/VC who would have preferred to bring skunion upon our heads. They tried and sometimes succeeded which was not what we desired.

Later, I rode with the Blackhorse 11th Armored Cavalry Regiment. We had a whole assortment of weapons. Take the Sheridan cavalry fighting vehicle, as I think it was officially called. We just called them Sheridans. I heard it had problems which I don't know much about, but it sure could bring trouble for the Dinks (Dinks were bad. Regular Vietnamese were good). Sheridans had a tank type turret with a 155mm main gun. One kind of round was called fleshette which had about 999 nails each having a tail like an arrow instead of a head like an actual nail. The Sheridan could put some of those fleshettes through a 12 inch beam from forty or fifty yards. I don't know if that's official, but that's what I saw happen on the perimeter at Quan Loi. Adding the machine guns and the personal weapons of the crew made that Sheridan a fearsome machine.

Or take our M48 tanks which had another fearsome main gun, 90mm as I recall. It also had machine guns. That was besides the heavy metal of the tank itself. By the way, I hope you'll pardon my lack of perfect detail here. It's been a long time and besides, I was a chaplain and not expected to know much about weapons anyway.

Speaking of weapons, which we are, how about our artillery? We had a bat-

tery of 155mm howitzers, self-propelled, of course. Those howitzers could bring hell-on-earth to whoever was on the receiving end which I'm glad wasn't me. One night when I was with F Troop, our How Battery was firing into the jungle on our far side. I'll never forget the bone-chilling whoosh of rounds going overhead and hitting just outside our own perimeter! Sometimes in War Zone C we brought out the eight inchers! There was a fearsome weapon! It fired with an unholy boom! Just the noise would scare me if I thought those rounds were aimed my way. Then there were the 175mm howitzers at Quan Loi. They wouldn't bring them out where we were. I don't remember why. What I remember is that they fired accurately so far that they didn't need to be where we were. The projectiles made a humongous roar when they went overhead too. You didn't want to be under their direction of fire at night if you were at Quan Loi. You'd never get any sleep.

I don't have time to talk about our engineer's Bangalore Torpedoes, mines (Claymore or otherwise), our mortars, automatic ambushes, or our ability to call in air strikes and arc lights. I haven't talked about our Cobra or scout helicopters. This isn't a manual, either. It's just stories from Viet Nam as I recall them, a major purpose being to stimulate your own good memories and stories as you recall them from Viet Nam. Others people will recall and write about the weapon details. If you want recommendations for what to read, let me know.

There is one more weapon I want you to be conscious of. I know many of you already know about it. Some of you probably know it better than me. That weapon fit in the Viet Nam war situation. It fit in the Iraqi Freedom, WWII, Civil War (yes, even back in the 1860s) and other war situations just as well. This weapon fits all of life. I hope you see that we are indeed in a war in our lives. I don't mean fighting each other. I don't mean one nation fighting another, either. I mean personally fighting the Devil and

the spiritual forces of this life. Those evil forces give us trouble from the day we're born to the day we die. Now it's time for me to quote from the Bible for two reasons: (1) The Bible explains it better than I can by a country mile; (2) The Bible is the word of God so has 100% authority which I don't: "For the word of God is living and active. 
