Let me begin this second in a series of articles with the heart felt thanks to those who made our visit to the 11th ACR in Iraq possible. Without their support and pull, it would have been impossible to gain the unprecedented access to our troopers that allowed us to

record their well deserved place in history. We were fortunate to be witness to and record their heroic actions and humanitarian acts of kindness and compassion. The media that reports the events in Iraq is often biased and paints the picture to the American public that portrays its own agenda. The daily acts of caring our troops bestow upon the Iraqi people rarely make the news.

This is PART 2 in a series of accounts of a three-week ride with the “Blackhorse Regiment” by two former members of the “Blackhorse” that served in Vietnam.

We went into this project with an open mind. We saw and recorded the daily and nightly operations without a preconceived picture of things others wanted us to see. We literally “fell in” with the troops and shadowed them as if we were part of the team. We were not treated to a news media Dog and Pony Show in a highly protected environment. Because we were former veterans of the great Blackhorse Regiment, we were immediately accepted and trusted like brothers. With that, we were able to talk on the same level with the troops and share their deepest thoughts and concerns.

We found that the morale was high and our 11th ACR brothers and sisters were highly dedicated to the missions and believed in their cause. They were also very respectful to us Vietnam veterans and hold us in high esteem. They also sought our blessings, guidance and advice on how they were performing. Our opinion was often requested as if for



Operation Iraqi Freedom

The Troopers of the 11th Armored Cavalry Regiment have returned from their year long deployment to Iraq where their contributions to operation Iraqi Freedom reaffirmed that the "Blackhorse" is still the premier training and fighting unit in the U. S. Army. Although the Squadrons of the Regiment were not operationally controlled by the Regimental HQ, which was employed as a Divisional Level Command and Control HQ, the Troopers demonstrated their outstanding professionalism in their security missions and in offensive combat operations in support of the overall mission to secure the freedom of the Iraqi people. Their successes in training Iraqi units will ultimately speed the return home of the majority of US and Coalition forces.

The Regiment's operations were eerily similar to those we conducted some 35 years ago. It takes the same amount of courage to patrol and secure the streets of Iraq's cities and highways as it did for us to leave the relative security of Blackhorse Base Camp at Xuan Loc or the airbase at Bien Hoa or Lai Khe, Di An, or An Loc on security or "search and destroy" missions. Some would argue that today's Troopers were even more at risk with "Up Armored" Humvees whereas we had ACAV's, M-48 Tanks, Sheridans, and M-106 Mortars as well as our own Howitzer Battery and Thunderhorse Air Cav Troop in immediate direct support. They faced a suicidal enemy to whom dying was as good as or better than survival, whereas our enemy wanted to kill us and LIVE! Urban and desert warfare vs. fighting in the jungle and rice paddies—each have their dangers. Leeches vs. sand fleas—which would you rather have? How about the monsoon season and humid 100 degree days vs. 120 degree weather with sand storms? Take your pick, war is HELL!

Bottom line is that the Regiment

upheld the tradition and legacy we established in Vietnam and Cambodia, and each and every soldier deserves our deepest thanks and gratitude. Just as we did, our current Troopers lost friends that were taken from their families all too soon. These young men who made the ultimate sacrifice are mourned by us and a grateful nation. Blackhorse Week and Welcome Home Activities

We all remember too well the way we were treated upon our return from Vietnam. Some of us were never thanked for our service, were shunned or despised by old friends and neighbors, called "baby killers", ignored or otherwise disrespected. The 11thACVVC has pledged that "Never Again" will returning soldiers be treated as we were so many years ago. Whether we agree with the war in Iraq, believe we are involved in a "World War" against terrorism, or support one political party over another; our soldiers deserve our support and thanks for their selfless service. We have decided to contribute to a Welcome Home Party for this country's newest heroes. All of us are welcome at the festivities to be held in and around Ft Irwin, CA, 16 – 19 March 2006. The Troopers will have all returned from the war zone, have had "block" leave to get reacquainted with their families and had a period of time to readjust to life and service in the United States (remember when we used to call it "Back in the World?"). Members of the 11thACVVC voted at the annual business meeting during the reunion in Colorado Springs to donate \$15,000 to help ensure a party and barbecue at no cost to our soldiers and

families. There will be a small charge for veterans to attend, and accommodations are largely up to each attendee. Elsewhere in this issue of *Thunder Run*, you will find a tentative schedule of events, a RSVP form that Ft Irwin needs to project the number attendees, and other information on the party and a Banquet which will be held in Las Vegas on the 23rd of March.

11thACVVC Activities

As you will read in this issue of *Thunder Run* our 2006 scholarship fundraising activities are in full swing. I thank all who have contributed towards this major activity by sending in a donation in the envelope provided with the calendar. ■ **Scholarship Fund Donations in Support of the Annual Calendar Appeal Enter Record Territory!**

Offer a hearty "Thank You!" to all of our generous Troopers, spouses, families, and friends who have contributed to support the 11thACVVC Scholarship Program through the annual Calendar. We are again in record territory as this issue of *Thunder Run* goes to press. In 2004 we set a goal of \$20,000 from calendar contributions, and we received \$23,245. Last year the goal was raised to \$25,000 and your generosity resulted in \$26,782—both were records! For 2006, we established a goal of \$30,000 and as we go to press, we are already over \$27,000! Thanks to all who have taken the time to send in their tax-deductible contribution in the envelope provided.

I would especially like to thank those one hundred sixty three who have been able to support the program with contributions of \$50 and more so far. About sixty five members have contributed \$100 or more with 3 three donating \$500.

The sum donated thus far for 2006 represents contributions from about 25% of our membership. For the other 75% who have not yet gotten around to it, don't despair! There is still time for you to remove the envelope from your

calendar, write a check and send it in to the address listed. It would be awesome if at least 50% could respond to this annual fundraiser. Doubling the number of participants would mean that we would not have to turn down as many deserving applicants and could open the door in the near future to including our Grandchildren in the program as many of our members have suggested.

For the past few years, we have been able to increase the number of \$3,000 scholarships awarded from fewer than 15 to last year's record of 25 recipients. To date, over \$375, 000 has been awarded to

support the education of our members and their children! The program and application forms are featured in this edition of Thunder Run and we invite you to take the time to become familiar with the program. For those who are not members of 11thACVVC, you must join the organization for you and your family to become eligible to participate. There are a limited number of calendars still available and one will be sent to each new member while supplies last.

The calendar is one of three fundraising projects we conduct each year. The other two are the annual Raffle with a grand prize of \$1,000 and the Silent Auction which we hold during the Annual Reunion.

I would especially like to thank those one hundred sixty three who have been able to support the program with contributions of \$50 and more so far. About sixty five members have contributed \$100 or more with 3 three donating \$500. I am sure there will be more generous donations before we close out the calendar – (they are still arriving at the pace of about 10/day) - appeal for 2006, so if you desire to contribute, you are not too late.

All contributions are appreciated and although I pointed out some of the larger sums, I know that the \$5 that some Troopers offer is just as great a sacrifice for them as the larger amounts are for others. We really thank you and appreciate your willingness to support the scholarship program. THANKS!

approval from a parent. It was very emotional being with these fine soldiers.

With that said, please try to attend and support the Welcome Home Celebration in March 16-18 at Fort Irwin. I believe these troopers consider our veterans respect and admiration above that of the general public.

Kuwait – Destination Iraq

We loaded up with other civilians at 2:00AM in a bus with closed curtains for a thirty minute drive to a military airstrip somewhere in Kuwait. We were some of the few that wore desert BDU's. The majority of the passengers wore civilian clothes and were American contractors. As you looked at the group you wondered who and what job they were headed for. We got the usual once over and sometimes after seeing the Vietnam Vet embroidered over our shirt pocket got an inquiry. Our standard reply was that we were just visiting. This drew more speculation and scrutiny until we explained our mission.

We spent hours waiting and discovered that flight times were always a secret and they would never tell if you were on a flight until it was time to board. We boarded a C-130 as the sun peeked over the desert and were on our way. (See Photo C-130)

In our request for special treatment to get us to the 11th ACR as soon as possible, we skipped the news media briefing

and credentialing process which would have cost us two days of our trip. This was a mistake that would haunt us repeatedly during our stay. We figured that once we were with our Blackhorse brothers, we didn't need any papers. Problem was, we later had to move from place to place under the control of other units and branches.

One example was the hassle we got entering the various dining facilities. Both military and civilian contractors eat there and carried identification that we missed out on in our haste to move forward. Military entered one door and civilians entered through another after they were wanded and or searched. We were usually escorted to chow with group that contained a Sergeant Major or higher. Boy did we feel like celebrities. Yes, we also dined with privates and enjoyed the interaction and conversation.

On one instance we were in the Green Zone where a lot of senior military dined, lots of brass and generals. The security was so tight there that even LTC Blackburn couldn't convince them we were OK. We were directed to the dreaded civilian door. After more exchanges between the LTC and the Lieutenant in charge of security, we were sent to the next station for the search. The 3rd Infantry Division sergeant I was face to face with stood motionless for a moment as he read the Vietnam Vet over my pock-

et. A disgusted look came over his face and he turned to the Lieutenant and shouted, "I'm not going to search these guys" and waved us in and said, "Go on in Sir." I reached out in mutual respect, shook his hand and said 'Thank you and thanks for serving our country'.

Now I am going to share a closely guarded secret with you. After seeing the dining facility and the bounty of everything imaginable, I thought it was best not to take any photos. I often told the troopers that I was not taking any pictures inside because "if the folks back home saw them, you will never get another Care Package". I would compare it to a quadruple Golden Coral. This was in Baghdad and not the norm at our other stops.

Day One

We arrived in Baghdad around noon and as is usual inside the military machine, we were on our own. We were supposed to start our visit in Mosul with the Regimental Headquarters but the flight was not going that far that day. Once I found a land line I called 2/11 ACR and requested someone bring us home. Within minutes a Humvee arrived with the familiar Blackhorse on the gun shield for the ride to Camp Liberty. The in-flight service on the C-130 was low budget, no frills and limited to the bottle of water you picked up at the back ramp.

2/11 was a little unprepared for our visit which was now a week sooner than expected. We were treated to lunch and issued newer body armor. We were told to get some rest and they were going to pick us up at 2:00 am to raid several suspected terrorist homes. "Welcome to our War!"

We were definitely sleep deprived by now but we knew we would have to check our camera gear in preparation for what was to come in a few hours. The video light was in excellent condition but the bulb did not survive the shock in the C-130. It really did not matter because the light would have given away our position and ruined the troops' night vision.

We rolled into the streets of Baghdad which were empty due to the curfew. The first glimpse of the city would be at night which would take on a whole new look

when the sun came up. We turned into a neighborhood and the street narrowed. The computer facing the front passenger glowed with the navigational three dimensional picture of building roof tops and the Humvee's ever changing position. This was star wars at its finest, driving with no lights through the streets of Baghdad with the 11th ACR.

We had linked up with an Iraqi army unit who unlike the ARVN's of Vietnam, did most of the searching while the 11th ACR backed them up. When we reached the suspected house there were vehicles scattered in defensive positions. The word came over the radio and doors flew open and the race was on along the six foot tall wall to the front gate that was chained. The team was prepared with bolt cutters and quickly stormed the front door and knocked and shouted in Iraqi. Dogs were barking throughout the neighborhood as the door opened and the team entered and began interrogating the occupants. My escort cleared me to enter and capture the process on video. The Iraqi army began searching the house. Most houses are not air conditioned with only ceiling fans to move the hot air. I began to notice the heat building up under my body armor and had thoughts of Vietnam. It was a very similar feeling. Perhaps this is why most of the occupants slept on the floor. It is the lowest point and therefore the coolest.

The interpreter got Intel from the resident that caused a stir and we were out

the door and running down the street to another home where they hoped to find a suspect. Too late, he was no longer there.

We left the neighborhood empty handed that morning but gathered more information for future raids. It was still dark as we headed for the infamous Abu Ghraib Prison. Last April the Marines fought off a fierce attack on the entrance and guard tower that made world news for weeks. Soon after that the 11th ACR was sent to relieve the Marines and took over perimeter security. The interior of the prison however is controlled by a private civilian contractor. We were given what is now considered a rare tour of the prison along with the 3rd Infantry Division Commander and viewed Saddam's Death House. After the invasion by Coalition

Forces documents were discovered in the form of ledgers that listed over ten thousand deaths in the prison. Those were just the ones that had been written down. They are still fearful of doing any excavation around the complex at this time for fear of uncovering mass graves.

Media tours were halted after the media hammered the military's handling of prisoners while under the control of a National Guard unit. While the prisoner's treatment was without question wrong, it amounted to nothing more than what takes place at a college hazing. As usual the media worked it into frenzy for months. The real story in the prison which gets hardly any notice is the deplorable conditions that existed when Saddam was in control. Saddam and his son's were very efficient at murder and torture as the various areas in the prison became Dante's Inferno to tens of thousands of Iraqis.

The Gallows and Baseball

This was an assembly line where two could be hung as quickly as one. The best comparison was to the batting order in our own American baseball. The scenario went like this. The first two unfortunate prisoners would step up to have the noose tightened around their neck with the executioner standing between at a podium with dual levers. When the trap door dropped, the bodies hung below on the next level. The next two prisoners in line to meet Allah, (On Deck), had the job of taking the dead prisoners down and dragging them to the door. They then moved to the gallows. From the door, the next

two prisoners in line, (In The Hole), would drag the bodies outside to a waiting truck. They would then become (On Deck). This process worked well until a prisoner resisted, applied a union job action and refused to participate. He would then be counseled by having his hands connected to a rope that would be looped around a steel hook projecting from the concrete ceiling. He would be hoisted above the floor and repeatedly struck with sticks and other objects of pain like a Mexican Piñata until he decided death by hanging was less painful. The counselors would take care not to damage the extremities while inflicting maximum pain. After all, this prisoner still had to be able to perform his part in the assembly line. We saw many of these ceiling hooks in various rooms throughout the prison.

During the tour we were taken to a hall that had no window and was ventilated by holes in the concrete block. The hall was about fifteen foot wide and half the length of a football field. Imagine this hall filled to capacity, standing room only of hot bodies without air conditioning. Saddam's cronies were sending so many prisoners that the warden could not handle any more. He called one of Saddam's sons to ask how he might handle the problem. Uday or Qusay shows up with his entourage and immediately has a solution for the warden. He pulls his pistol and does a head count one, two, three bang.

He proceeds to repeat this down the hall as his assistants reload the magazines

The Vets are Coming

Our early arrival in Baghdad at 1/11ACR was a surprise to the troops. Very few knew about us or why we were really there. Perhaps we were spies for the brass and really doing an IG inspection. It later proved to be a real morale booster. On our first daylight mission in the early morning hours we made our way to the three Humvee's. The crews were gathered around for the briefing and the team leader announced that two Vietnam vets would be riding with them today. We got a few bewildered glances as the briefing continued. When the briefing concluded they manned their vehicles as we waited to be directed to ours. When I entered the back seat behind the driver I introduced myself and told them my name was Eric and not Sir. The crew still seemed a bit uptight and bewildered having never experienced a situation like this. I added that I had served in Vietnam with the Regiment and had a combat MOS. I also told them not to baby-sit me and stay focused on their job. "If the S— hits the fan, just pass me a gun, I can take care of myself." With that the ice was broken and their silence changed to "Hooah." The gunner above me then added, "When they said some Vietnam vets would be riding with us today, we figured, these guys have got to be at least sixty or seventy years old by now". Their mind now at ease, I said that we left our walker and wheelchair inside HQ's

General Account

The General Account consists of income for Membership, Quartermaster sales, Donations and Bank interest. We pay out expenditures for Administration, Quartermaster, Newsletter, Raffle, Calendar and bank charges.

Investments:

Our investments consists of interest and share income for twenty-two Certificates of Deposit (CDs) and three Mutual Funds. These mutual funds and CDs are from Life memberships and are intended to be used to operate 11 ACVVC past and present.

Your 2006 Forecast:

I expect income for Membership monies to decline as we are signing up fewer troopers each year. We have many, many more troopers transferring their annual memberships to Life. Our Quartermaster sales will remain about the same as 2005. Donations continue to rise as well. Monies from our Quartermaster are expected to remain the same as 2005. Much effort is being given to increase the number of scholarships awarded, thus more donations will be solicited for next year. Reunion funds are expected to be about the same as 2005 as our numbers at reunions are leveling to about 900 plus people. Our monies to assist troopers to attend a reunion will increase we think as we have adequate funds to support more assistance. The monies that we collect at the reunions each year are leveling out to about \$1,500. Our investment funds are expected to increase due to many CD's paying dividends in 2006. The above funds reporting indicate to us that our organization's finances are in great shape and will continue to support us in the future years.

January 2006. Another year is upon us. Wonder what this one has in store for us?

Normally I use this space to bring you up to date with my family and work or maybe to toss out ideas for the ladies meeting at the next reunion. But this time my heart just isn't in it.

You see three weeks ago the war in Iraq hit home for our family. A close neighbor and friend was notified that his son had been killed in Iraq. He was a Marine and was on foot patrol when a bomb went off. He and nine of his fellow troopers paid the ultimate price. His name was Andy and he was twenty nine years old.

At the visitation, I looked through many books of pictures of Andy as a young kid playing soldier in his backyard. I could see that this was something he always dreamed of being. I could remember very plainly the day his dad told us Andy was joining the service. Such a proud air he had about it.

At the funeral his sister recalled how when they were all small Andy would make them all march around the yard in formation. Yes, this was something he was destined to be. He always knew that when he graduated from high school he would join the service and he did, the week after graduation. When he was still in high school and later when he would come home on leave he would come into our yard when Bob was outside cutting the grass or whatever and they would talk military.

Everyone in town knew Andy and his family. His dad taught drivers education and training at the local high school. He probably taught 90% of the kids in town to drive. I know he taught mine.

At the funeral, as one of his fellow troopers talked about him, this fact was brought up. It seems he was told to move a Humvee and as he and three others were riding Andy accelerated to the point that the vehicle went onto two wheels. His LT. commented on the fact the he never lost control and asked him where he learned to drive like that. His calm reply was "in high school driver's ed. Sir". After about ten minutes he turned to the officer and said

with a grin, "Did I happen to mention that my drivers' education teacher was also my dad?" He was truly a remarkable young man.

I never saw such an outpouring of love and support for Andy's family as our town showed when the news came. The line for the visitation was about six blocks long. Never mind that it was freezing cold everyone wanted to say good-bye. The streets were lined with town's people all holding flags all the way from the church to the funeral home, a distance of about 2 and one half miles. School was cancelled that day. They say because of snow, but I think even if school hadn't been cancelled there would have been a lot of empty seats from people who had gone to the funeral to honor the fallen hero. The flags in town were all put to half staff, and there were signs of thanks and support to this hero and his family everywhere you looked. He was laid to rest in a town about two hours from here the next day, and there were well over 250 people in attendance.

It certainly brought the gayety of the holiday season to a new awareness for me. It made me stop and count my blessings. It made me ever more thankful for the love of a good man, two beautiful sons, a remarkable daughter-in-law, and three wonderful grandchildren, all healthy, happy and free thanks to people like Andy who are willing to put their lives on the line for us.

Well my friends, I know this is short, but I want to leave you all this time with my love and my hope and prayers of freedom and happiness. My thanks to all of you ladies, gentlemen, and families without whom our country would not be as great as it is.

this quarterly newsletter Thunder Run. The newsletter keeps you informed of your organization, its members, and the activities of the 11th Cavalry, both past and present. We pride ourselves on our continued commitment to bring the news to our members through this newsletter which has been printed and mailed every quarter for the past 20 years. It shows our reliability, stability and commitment.

When you become a member or renew your membership you will receive your new membership card. All members are assigned a membership number that appears on their membership card. LIFE members receive a plastic membership card with their name and membership number embossed.

Life Membership Payment Plan

The number of LIFE memberships has increased rapidly over the past years. Over two-thirds of our members are LIFE members. This increase is due in part to our LIFE Membership Payment Plan.

SERVICE

Did you ever wonder why they call it “the service?” Like, “He’s going in the service” or “My kid’s in the service” or “I went into the service?” When I was a kid during World War II, I clearly remember people talking about someone going into the service. I knew what they were talking about; they were talking about going into the Army or other military force. Or, think about this one: Why do you leave a tip when you’ve had a great meal at a nice restaurant? Naturally, it’s because you had good service which you appreciated. [Or you left no tip because the service was lousy or you’re just too tight - huh?]. So what does the Army have to do with eating out? Simply put, they were both a form of service.

“So what do you mean by service, you ask?” Thanks for asking. I respond that service is doing something for someone else that helps them or makes their life better - maybe a lot better or maybe just a little better, but better. I agree that military service, especially fighting and maybe dying for someone’s freedom, is a whole lot bigger than putting someone’s meal in front of them, but they’re both ways of giving service, of doing something that makes someone’s life better, even if it’s only a little bit better.

Since the sole (which means only) purpose of the Army (like the rest of the military) is to serve our country, it’s just called “The Service.” “Why?” you ask. “I don’t know,” I reply, “It just is.” I personally think it’s a good term. It fits. It’s what we do, being members of the Army. The same applies to the other services.

Now, here we are, veterans, ex-service members, unless you’re still young and on active duty, that is. (Cheer up - someday you’ll be a veteran too. Be patient). One thing where we have a huge advantage over a lot of our civilian friends is that we have a handle on what service means. We’ve been down that road. Another thing plenty of veterans have a handle on is memories, whether great, good, neutral, bad or extreme. Some vets

even have PTSD which means having a hard time adjusting to those hard times of serving which maybe took more out of you than you could handle then. Now you’re looking for a way to get rid of the ghosts and demons of those times. Some of you are looking for how to quit living in the past, come into the present and look to a hopeful future. Talking about PTSD usually brings Viet Nam vets to mind. Being a Nam vet myself, I clearly understand this. Our war didn’t create PTSD (it used to be called shell shock or combat fatigue) but it did make our whole civilization very aware of the problem. Now younger generations of war-fighters (Service members) are living with the same burden.

So what’s being done about it? I mean, what are people doing to help vets with this problem to get past it? Mostly, what are the vets with the problem doing about it for themselves? There are a lot of programs and people out there who help. There are plenty of vets who’ve gotten past their PTSD, their ghosts, their grief, and their guilt. There are VA Counseling Centers, Point Man Outposts, churches, vets organizations, psychologists, pastors and even military debriefing teams that truly help (I’m not including the ones who only talk and blather).

There’s something else I’ve seen from time to time that helps vets get past their life’s demons and ghosts. It’s something that they understand very well, indeed. It’s something that every vet can actually do which is healing and fulfilling. It’s worth committing to and it works. It’s called service. “Huh?” you say. “That’s right,” I say. “You just got through spouting off about service being something that people do for others. Now you’re saying that I’m supposed to serve others, just like I did in the military service? Hey (or hay)! I’m the one with the problem! What gives?” you say. What gives is this. I believe what I’ve observed and experienced which is that the principle of “it’s better to give than to receive” is not just a pious platitude; it’s a life principle that works.

Let me tell you a true story. I’ve seen plenty of vets get into group therapy and share their story, which is hard to do. There’s no way to over state how important it is to talk it out. Too many carry their stories stuffed and untold for years, maybe decades. They’ve just sat there in the group, poisoned and festering. You know what I’m saying. These experiences and memories have to be unstuffed, shared with others who care and who might have walked that same road. As important as that is, once you deal with your story, then you need to move on. Too often vets keep going over the same ground time after time, week after week, and year after year. They’re stuck at the entry level of healing when there’s more living to be done. You have to move on! That’s where service comes in.

In the early eighties I was stationed in Schweinfurt, Germany. I’d served two tours in Viet Nam and was on my second tour along the East German border. In Schweinfurt I’d been talking with soldiers who were being hounded by their memories and their ghosts. I’d seen that it helped to get those infections lanced and the pus of grief and guilt expunged. I saw also that if they were to grow beyond the lancing stage, they had to move on. I observed that in proportion as the vet (some still on active duty) got involved outside himself by serving others he gained purpose, healing, and a brighter future. My observations were personal and gave me a renewed realization that even the most severely distressed vet can find hope and healing.

There’s a place in the Bible that makes the point. It’s in I Peter 4:7-10 in the New Testament where it says “Be clear minded and self-controlled so that you can pray. Above all, love each other deeply, because love covers over a multitude of sins. Offer hospitality to one another without grumbling. Each one should use whatever gift he has received to serve others, faithfully administering God’s grace in its various forms.” This is good advice. It applies to you just as much as it does to me. Uh oh. I can hear

the excuses coming even as I speak. I can't reply to everyone, so I'll just point out that you can be clear minded, you can think and reason rationally, you can pray and you can serve. I know for a fact that you can love deeply because some of the deepest love I've ever witnessed was on the battlefield. You were there so you know.

So now, I trust that you'll consider just where you are in all this. Are you still stuck in the past? Please get unstuck, talk to someone, visit a memorial, go to a reunion, and break through the barrier. Then take the steps you need to move into the present, to accept healing and to find your purpose and the joy of living. Big steps come through serving - serving God your Maker and serving others around you. I've observed this and I know it works. It works for me and it will work for you. Do it. Service is an answer.

God bless you. God loves you. So do I.


